# Professorship in Late Effects After Cancer and Cancer Treatment

To ensure a clear, well-founded and targeted application for a professorship, it is important that you read and follow the guidance below. This provides the assessment committee with the best possible basis for making a comprehensive evaluation.

It is recommended to divide the text in the fields into visible sections using numbering, and to use Caps Lock in some headings to make the assessment committee's reading easier and clearer. It is not possible to format text in bold, italics or underline.

## Description of the Professorship and Research Plan (Max. 15,000 characters)

In this field, you must describe your research plan for the focus area 'Late effects after cancer and cancer treatment' for the next 5 years. Your description should provide a clear picture of the plan for the professorship, and in this field, you must address the elements listed below. Please note that the description of the individual work packages should be provided in the following field.

#### Vision, purpose and research questions

Describe the overall vision, purpose and the key research questions for the professorship.

#### Background, existing and new knowledge

Briefly describe the existing knowledge in the field and explain how the professorship will build upon this knowledge. Describe how the professorship will contribute new knowledge and initiatives that strengthen the development of the focus area.

#### Interdisciplinary and cross-sectoral collaboration and networks

It is a high priority for the professorship to contribute to collaboration across disciplines and sectors. Therefore, describe national and international collaborative relationships (please name institutions and partners where possible). Explain how you will establish and strengthen interdisciplinary and cross-sectoral collaborations and networks, including any collaboration with industry or public sector actors. Important national and international collaborators should also be listed in 'Responsible Manager & Collaborators'.

#### Anchoring and national knowledge sharing

Explain how knowledge and results from the professorship will be anchored and shared nationally, so that the field is broadly strengthened in Denmark. Describe initiatives that will ensure the dissemination and implementation of new knowledge.



#### Success criteria

Describe the potential for strengthening the focus area and clarify the success criteria for the planned research and activities. Explain how the professorship will contribute to one or more of the following

- Research into the prevention of late effects
- Research into the extent and nature of late effects, including which patients are at particular risk
- Research into the mechanisms behind the development of late effects
- Research aimed at the treatment and management of late effects for both patients and relatives
- Research into interventions that improve the quality of life as well as functional and work ability for patients with late effects
- Research into better organisation of late effects initiatives including the establishment of evidence-based cross-sectoral pathways between hospitals, municipalities and the primary care sector, both locally and nationally
- Implementation projects, where existing evidence is implemented effectively, preferably
  with a national focus this may also include the implementation of clinical guidelines
  and systematic monitoring of effect with a view to ongoing improvements

## Description of the Work Packages (Max. 20,000 characters)

In this field, you must provide a clear overview of the planned work packages included in the professorship.

#### Work packages

For each work package, describe who is responsible as well as the purpose, methods, feasibility, organisation, collaboration, and significance for the area 'Late effects after cancer and cancer treatment'. Where relevant, ethical considerations, risks and their management should also be included in the description.

For each work package, it must be stated what role the applicant has, if the applicant is involved in the work package. If the applicant does not have a role in the work package, this must also be stated.

#### Coherence and timeline

Briefly describe the coherence between the individual work packages and how they contribute to the overall purpose. Attach an overall timeline (e.g. Gantt chart) for the work packages.
